IN THE SUPREME COURT OF THE MUSCOGEE (CREEK) NATIONAL COU

ADMINISTRATIVE ORDER 2020-02

- 1. Muscogee (Creek) Nation Principal Chief, David Hill issued Executive Order No. 20-01 on March 13, 2020, declaring a State-of-Emergency within the Muscogee (Creek) Nation resulting from the COVID-19 virus and its threat to citizens of the Muscogee (Creek) Nation, the Nation's employees, and the population generally.
- 2. The purpose of this Administrative Order is to clarify the temporary procedures to be followed within the Muscogee (Creek) Nation Supreme Court and to encourage social distancing in an effort to limit unnecessary risk of exposure to the Nation's judicial officers, court clerks, court personnel and the public.
- 3. Subject only to Constitutional limitations, all deadlines and procedures prescribed by statute, rule, or order respecting appellate rules and procedure shall be suspended until **Friday, May 1, 2020** (subject to additional Emergency Administrative Orders issued by this Court, as needed). Should a party's deadline or procedure fall during the suspended period, the party's new deadline shall be Friday, May 1, 2020 (subject to additional Emergency Administrative Orders issued by this Court, as needed).

Please explain the nature of the emergency action and the Court staff member will advise the procedures required to safely file the action with the Court, or notify you that the action will be subject to the suspension detailed in paragraph 3.

5. The Office of the Supreme Court Clerk will be closed to the public until after the suspension period is lifted on May 1, 2020 (subject to additional Emergency Administrative Orders issued by this Court, as needed). The Chief Justice of the Supreme Court shall have the discretion to modify in-office staff schedules, to require teleworking, or any other options to facilitate the safety of the Judicial Officers, staff, and the public. All contacts with the Court should be through electronic means, at the email addresses detailed above during the suspension period (unless instructed otherwise).

- 6. Prospective MCN Bar Applicants may continue to submit their Application Packets to the Court as detailed in the Application instructions. However, these Applications will be held until after the suspension period is lifted on May 1, 2020 (subject to additional Emergency Administrative Orders issued by this Court, as needed). In the event a Prospective MCN Bar Applicant is also submitting an emergency matter (as detailed in paragraph 4), the Prospective MCN Bar Applicant should contact Deputy Court Clerk, Laura Marks at lmarks@mcnsupremecourt.com, and explain the nature of the emergency and, if appropriate, instructions will be provided to the Prospective MCN Bar Applicant for safely submitting the Application, required documentation, and payment to the Court for immediate consideration.
