- 1. On March 13, 2020, Muscogee (Creek) Nation Principal Chief, David Hill issued Executive Order No. 20-01, declaring a State-of-Emergency within the Muscogee (Creek) Nation resulting from the COVID-19 virus and its treat to citizens of the Muscogee (Creek) Nation, the Nation's employees, and the population generally.
- 2. On March 25, 2020, this Court issued Administrative Order 2020-02, suspending all deadlines and procedures prescribed by statute, rule, or order respecting appellate rules and procedures until Friday, May 1, 2020 (with the exception of certain emergency matters). This Order was subject to modification or extension as additional COVID-19 related developments occurred and was subsequently extended until Friday, May 15, 2020, by Administrative Order 2020-03.
- 3. On April 2, 2020, Muscogee (Creek) Nation Principal Chief, David Hill issued an "Essential Department Model" memorandum, identifying certain Nation departments as essential during the COVID-19 pandemic and instructing all other departments to work remotely until further notice and their buildings closed to the public.
- 4. In compliance with all previous Orders and memorandums issued by the Nation concerning the COVID-19 pandemic, and consistent with its continuing effort to encourage social distancing to limit the unnecessary risk of exposure to the COVID-19 virus, this Court is extending the suspension period on all appellate deadlines and procedures as described in Administrative Order 2020-02 and Administrative Order 2020-03 until **Monday, June 1, 2020**. Should a party's appellate deadline fall during the suspension period, and/or, in the event the Principal Chief rescinds Executive Order 20-01 and the April 2, 2020, "Essential Department Model" memorandum prior to June 1, 2020, the party's new appellate deadline shall be Monday, June 1, 2020 (subject to additional Emergency Administrative Orders issued by this Court, as needed).
- 5. All emergency matters and contacts with Supreme Court personnel shall continue pursuant to the procedures described in Administrative order 2020-02 until further notice.
- 6. This Administrative Order is subject to revision and/or extension as may be required during the Nation's State-of-Emergency.
