ADMINISTRATIVE ORDER 2023-05

CONNIE DEARMAN MUSCOGEE (CREEK) NATION

M(C)NCA Title 27, App. 2, Rule 17 (C) (2) and (3) provides that records of appellate cases involving juveniles, guardianships, and adoptions are to remain confidential absent order of this Court. Upon further consideration, the Court is of the opinion that citizens, attorneys, and litigants are placed at an undue disadvantage when they are not provided access to this Court's final *Opinions* establishing legal precedent that may be instrumental in an individual's real-world decision-making process and/or legal strategy before the courts of the Muscogee (Creek) Nation. As such, the Court makes the following change to M(C)NCA Title 27, App. 2, Rule 17 (C) (2) and (3):

- 1. The Court authorizes the release of all final *Opinions* (past, present, and future) of the Muscogee (Creek) Nation Supreme Court involving juveniles, guardianships, and adoptions.
- 2. All *Opinions* released pursuant to this Administrative Order shall be redacted of all personal identifiers, including names, addresses, dates of birth, social security numbers, financial information, driver's license information, medical records, employment history, and/or any other information that could be used to link an individual to the *Opinion* in question.
- 3. Any litigant currently before the Supreme Court at the time of the filing of this Administrative Order may request a thirty (30) day extension to their current briefing schedule, or, in the event their brief-in-chief has already been filed, may request a thirty (30) day period to file a Surreply. Requests for extension or Surreply must relate to new arguments specifically connected to precedent located within any previously confidential *Opinion*. Requests for extension or Surreply must be made via *Motion* filed with the Clerk of the Supreme Court within fifteen (15) days of the filing of this Administrative Order.
