

MCN BAR ASSOCIATION APPLICATION CHECKLIST

□ COMPLETE APPLICATION

- Answer *all* questions truthfully and completely. Answers must be typed using the fillable form, <u>not handwritten</u>. If unable to submit a typed application, contact the Supreme Court Clerk at 918-758-1439 for permission to submit a handwritten application.
- If you answer "yes" to Question 9, provide a full typed statement for the Justices' character and fitness review, separately explaining EACH grievance/disciplinary event. If you are an Oklahoma Bar Association Member, this would include (but not be limited to) all events listed on "Exhibit A" of your Oklahoma Bar Association Certificate of Good Standing. If any event is listed on "Exhibit A" you are required to answer "yes" on question 9.
- Familiarize yourself with the Nation's Constitution, Laws, and Court Rules at www.creeksupremecourt.com and www.creekdistrictcourt.com.
- Sign your original signature on Page 4 of the Application.
- Sign the Consent to Jurisdiction form on page 6 before a Notary Public. Please note that amendments to the Consent to Jurisdiction form will not be accepted.

□ SUBMIT AN ORIGINAL CERTIFICATE OF GOOD STANDING

- If you are an Oklahoma Bar Association Member: submit an official, original Certificate of Good Standing with Disciplinary History (not a photocopy). This Certificate can be ordered online at www.okbar.org, or by calling the Oklahoma Bar Association at 405-416-7000.
- If you are not an Oklahoma Bar Association Member: submit an official, original Certificate of Good Standing (not a photocopy) issued by the bar licensing authority of any state of the United States or the District of Columbia including the bar member's disciplinary history, if available.

□ SUBMIT APPLICATION FEE

A \$75.00 check or money order must be submitted with the completed Application.

□ SUBMIT APPLICATION PACKET

<u>NOTICE</u>: From the date of application, <u>up to thirty (30) business days may be required</u> to complete the admission process and become eligible to appear before the Muscogee (Creek) Nation courts.

At the time an application for admission to the Bar is filed, the applicant shall also provide the following supporting documentation:

- If a member of the Oklahoma Bar Association: an official, original certificate of good standing issued by the Oklahoma Bar Association, including the OBA member's disciplinary history, dated no more than ninety (90) calendar days prior to the date of application to the M(C)N Bar.
 If not a member of the Oklahoma Bar Association: an official, original certificate of good standing issued by the bar licensing authority of any state of the United States or the District of Columbia (including the bar member's state and/or District of Columbia disciplinary history, if available) dated no more than ninety (90) calendar days prior to the date of application to the M(C)N Bar;
- 2. A "Consent to Jurisdiction" form signed and dated by applicant (provided on page 6 below); and
- 3. A \$75.00 check or money order made payable to the M(C)N Bar Association (consisting of a one-time, non-refundable \$50.00 application fee and a \$25.00 membership fee refundable upon denial of the application for admission).

Completed applications and supporting documentation may be submitted either in-person at the M(C)N Supreme Court's office or mailed to: M(C)N Bar, Attn: Admissions, P.O. Box 546, Okmulgee, Oklahoma 74447.

<u>NOTICE</u>: From the date of application, <u>up to thirty (30) business days may be required</u> to complete the admission process and become eligible to appear before the Muscogee (Creek) Nation courts.

CONSENT TO JURISDICTION

I, the undersigned attorney, acknowledge that I must first apply for and be admitted to the Muscogee (Creek) Nation Bar and swear or affirm the Oath of Admission before I may represent clients or otherwise engage in the practice of law before the courts of the Muscogee (Creek) Nation.

Pursuant to this notice and the Muscogee (Creek) Nation Code Annotated Title 27, § 1-102, I unreservedly consent to the jurisdiction of the Muscogee (Creek) Nation courts, including the original jurisdiction of the Muscogee (Creek) Nation Supreme Court to discipline for cause any and all attorneys duly admitted to the Muscogee (Creek) Nation Bar found to have engaged in professional misconduct in any jurisdiction.
