## ORDER SETTING ORAL ARGUMENT

IT IS HEREBY ORDERED, in accordance with M(C)NCA Title 27, App 2, Rule 19, that the above-captioned appeal is set for oral argument on Friday, July 26, 2024, at 10:00 a.m., CST, in the Mound Building Auditorium, Capitol Complex, Okmulgee, Oklahoma.

IT IS FURTHER ORDERED that, absent extraordinary cause shown, the Court will decline to consider any request for continuance of oral argument in this matter filed after close of business on Friday, May 3, 2024.

In keeping with this Court's long-standing precedent, **IT IS FURTHER ORDERED** that the following Rules of Court shall be in place within the Mound Building and the Mound Auditorium/Courtroom on Friday, July 26, 2024:

- 1. All audio or video recording, photography, and/or reproduction of the Oral Argument is strictly prohibited.
- 2. All electronic devices of any kind (laptops, cameras, video recorders, cell phones, tablets, smart watches, etc.) are strictly prohibited inside the Auditorium/Courtroom, except for named parties, their counsel of record, and the Court and Lighthorse Police.

- All food and/or beverages are strictly prohibited inside the Auditorium/Courtroom, except
  for approved beverages for named parties, their counsel of record, and the Court and
  Lighthorse Police.
- 4. Visitors are strictly prohibited from entering the lower floor of the Auditorium/Courtroom, and must remain within the public seating area.
- 5. Visitors displaying political and/or inappropriate buttons, accessories, or clothing will be asked to remove the items or, alternatively, will be required to immediately exit the Auditorium/Courtroom. Further, as a sign of respect to the Court and Nation, no hats, hoodies, or head-coverings are allowed within the Auditorium/Courtroom.
- 6. Any outbursts during the Court session will result in the immediate removal of the individual from the Auditorium/Courtroom.
- 7. Regardless of permit status, no knives, razors, box cutters, fireworks, firearms, or other weapons, and/or weapon-like devices shall be allowed within the Mound Building.
- 8. No aerosol containers shall be allowed within the Mound Building.
- All visitors attending the Court session will be screened prior to accessing the Mound Building, and will be turned away if any of the above-referenced prohibited items are located.
- 10. Once the oral argument session has initiated, visitors will no longer be authorized to enter the Auditorium/Courtroom.
- 11. Following completion of the oral argument session, visitors will be required to immediately exit the Auditorium/Courtroom, and, if not conducting any official business with the Courts and/or National Council, shall also be required to immediately exit the Mound Building.

Finally, as this oral argument is anticipated to bring large crowds and significant media

coverage to the Capitol Complex, IT IS FURTHER ORDERED that the following rules shall be

in place specifically for this oral argument session:

1. No video or still cameras shall be authorized within the Mound Building on July 26, 2024.

Any media coverage may take place on the east side of the Mound Building, outside of the

main entrance. This is to ensure public safety inside the Mound Building, where large

crowds are expected to form.

2. In an effort to process visitors through security in a timely fashion on July 26, 2024, no

briefcases, bags, purses, or overcoats shall be allowed within the Mound Building, except

for named parties, their counsel of record, and the Court and Lighthorse Police.

Failure to adhere to any of the above-referenced Rules of Court and/or special rules for the July

26th session may result in a finding of contempt of court, including possible fine and/or jail time.
