CLASSIFICATION: #37. TRIBAL GOVERNMENT

A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 37 § 2-130 ENTITLED, "Special Academic/Extra-Curricular Program" AND APPROPRIATING SUPPLEMENTAL FUNDS FOR FISCAL YEAR 2018

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>FINDINGS</u>. The National Council finds that:

- A. NCA 00-136 established the Special Academic/Extra-Curricular Program to allow one-time funding for Muscogee (Creek) citizens who are not eligible for any other tribal academic services under the Department of Education, Employment, and Training.
- B. The Special Academic/Extra-Curricular Program has received supplemental appropriations and additional funding in the Comprehensive Annual Budget annually in the total amount of One Hundred Twenty-Five Thousand and No/100 Dollars (\$125,000.00) and still continues to be fully utilized before the fiscal year is over.
- C. MCNCA Title 37 § 2-130 is in need to be amended in order to allow additional funding for the program annually.

SECTION TWO. AMENDMENT. The following new law shall be codified in Title 37, § 2-130 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said new law and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following new law, without further National Council approval:

§ 2-130. Special Academic/Extra-Curricular Program

The National Council hereby appropriates and authorizes the Principal Chief to expend One Hundred Fifty thousand dollars (\$150,000) for the Special Academic/Extra-Curricular Program for FY 2019. This appropriation shall be included annually in the Comprehensive Annual Budget thereafter, depending on the availability of funds. Any unexpended funds at the end of the fiscal year shall be returned to the Tribal Treasury.

SECTION THREE. <u>APPROPRIATION</u>. The amount of Twenty-Five Thousand and No/100 Dollars (\$25,000.00) is hereby appropriated from the Interest on Permanent Fund Account. All unexpended funds appropriated by the implementation of this Act shall be returned to the Tribal Treasury and shall be available for future appropriation by the National Council.

SECTION FOUR. <u>AUTHORIZATION</u>. The National Council hereby authorizes the Principal Chief or his designee to expend the sum of Twenty-Five Thousand and No/100 Dollars (\$25,000.00) from the Interest on Permanent Fund Account in accordance with the attached budget for fiscal year 2018.

SECTION. FIVE. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.


