

CLASSIFICATION: #19. ELECTIONS

A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 19, § 2-103 TO INCREASE THE STIPEND OF THE ELECTION BOARD MEMBERS

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>AMENDMENT</u>. These amendments shall be codified in Title 19, Chapter 2 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by west Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. <u>AMENDMENT</u>. MCNCA Title 19, § 2-103 is hereby amended to read as follows:

§ 2-103. Compensation of Election Board Members

Each member of the Election Board shall be paid a stipend for attendance of each meeting of the Election Board. The stipend for each Election Board member shall be two three hundred dollars (\$2300.00) per meeting and shall increase to four hundred fifty dollars (\$450.00) on election days. Provided, however, stipends shall not be paid for more than fifty (50) meetings per year.

SECTION THREE. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.



A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 19, § 2-103 TO INCREASE THE STIPEND OF THE ELECTION BOARD MEMBERS

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>AMENDMENT</u>. These amendments shall be codified in Title 19, Chapter 2 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by west Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. <u>AMENDMENT</u>. MCNCA Title 19, § 2-103 is hereby amended to read as follows:

§ 2-103. Compensation of Election Board Members

Each member of the Election Board shall be paid a stipend for attendance of each meeting of the Election Board. The stipend for each Election Board member shall be three hundred dollars (\$300.00) per meeting and shall increase to four hundred fifty dollars (\$450.00) on election days. Provided, however, stipends shall not be paid for more than fifty (50) meetings per year.

SECTION THREE. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
