**CLASSIFICATION: #37. TRIBAL GOVERNMENT**

**A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 37 § 2-215. ENTITLED "Mound Building Oversight Committee and Revolving Fund"**

**Be it enacted by the National Council of the Muscogee (Creek) Nation:**

**SECTION ONE. AMENDMENT.** This amendment shall be codified in Title 37, Chapter 2, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

**SECTION TWO. AMENDMENT.** MCNCA Title 37 § 2-215 B. is hereby amended to read as follows:


**§ 2-215. Mound Building Oversight Committee and Revolving Fund**

B. Creation. There is hereby created the Muscogee (Creek) Nation Mound Building Oversight Committee. The Muscogee (Creek) Nation Mound Building Oversight Committee shall consist of the Speaker of the National Council or designee and one member from each of the National Council Standing Committees, Chief Justice of the Supreme Court or designee and Administrative Officer of the District Judge Trial Courts or designee. The Committee shall select a Chairman and record minutes of all meetings.

**SECTION THREE. EFFECTIVE DATE.** This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

**ENACTED** by the Muscogee (Creek) National Council on this 28<sup>th</sup> day of April, 2018.




