

CLASSIFICATION: #37. TRIBAL GOVERNMENT

A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 37, § 2-221, ENTITLED "REINTEGRATION PROGRAM REVOLVING FUND ACCOUNT"

Be it Enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. This amendment shall be codified in Title 37, Chapter 2, of the Code of the Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. AMENDMENT. MCNCA Title 37 § 2-221 is hereby amended to read as follows:

§ 2-221. Reintegration Program Revolving Fund Account

A revolving fund account for the Muscogee (Creek) Nation Reintegration Program shall be established. Expenditures shall be made by the Reintegration Program in compliance with Muscogee (Creek) Nation Procurement Policies & Procedures. The donation funds shall be utilized for the future fundraising activities hosted by the Reintegration Program and for the purchase of toys for the Annual Christmas Reintegration Program Toy Drive and for the purchase of incentive items, such as gift cards, toys and other items, for the Reintegration Program Clients.

SECTION THREE. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
