A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 11 CHAPTER 7, ENTITLED "TULSA SMOKE SHOP ACT"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>AMENDMENT</u>. This amendment shall be codified in Title 11, Chapter 7, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

TITLE 11. COMMUNITIES

CHAPTER 7. TULSA SMOKE SHOP ACT

§ 7-101. Tulsa Creek Indian Community smoke shop

- A. The Principal Chief is hereby authorized to enter into a land use agreement with the Tulsa Creek Indian Community for the purpose of developing and operating a community smoke shop. The land use agreement shall include the right to the Tulsa Creek Indian Community to use property owned by the Muscogee (Creek) Nation at a site known as the "Mackey Sand Bar Site" and/or the Tulsa Bingo. The agreement shall not be amended or modified unless authorized by Tribal Resolution. The Principal Chief is further authorized to terminate the agreement prior to the expiration of the term of the agreement; provided that written notice of termination shall be delivered to the Tulsa Creek Indian Community ninety (90) days prior to the effective date of the termination. The National Council shall be informed of the effective date of the termination. The National Council shall be informed of the intent to terminate, with justification.
- B. The location of the community smoke shop shall be in the northernmost portion of the "Mackey Sand Bar Site," as described as follows:

A tract of land in the South Half of Section 7, Township 18 North, Range 13 East, of the I.B.&M. Tulsa County, State of Oklahoma,

being described as follows, to-wit: commencing at the Southwest Corner of Lot 1, Block 1, The Shoals, an addition to the City of Tulsa, State of Oklahoma, thence S88°53'30"W a distance of 423.31 feet feet to the point of beginning; thence N01°06'30"W a distance of 114.31 feet; thence S88°53'30"W a distance of 114.31 feet; thence S01°06'30"E a distance of 114.3; thence N88°53'30"E a distance of 114.3 feet to the point of beginning. Containing 0.3 acres more or less. A tract of land in the South Half S/2 of Section 7, Township 18 North, Range 13 East of the Indian Base and Meridian, Tulsa County, State of Oklahoma according to the U.S. Government Survey thereof, being more particularly described as follows, to-wit:

Commencing at the Southwest corner of Lot 1, Block 1, The Shoals, an addition to the City of Tulsa, Tulsa County, Oklahoma, Plat Number 4248, thence S40°23'17"E a distance of 64.59 feet to a point on the South line of said Section 7, thence S 88°53'30"W along said South line for 288.54 feet to the Southeast Corner of the TCIC Trust Acquisition Site and the Westerly right of way line of Riverside Drive, Thence N 37°14'58"W along said Westerly R/w for 282.90 feet, thence S 57°40'44"W for 35.21 feet to the point of beginning;

Thence 57°40'44"W for 35.21 feet, thence N 29°12'35"W for 24.41 feet, thence N 29°52'24"W for 32.21 feet, thence N 31°47'33"W for 36.79 feet, thence N 32°07'28"W for 37.25 feet, thence N 37° 58'28"W for 29.36 feet, thence S 57°09'58"W for 35.32 feet, thence S 57°14'59"W for 30.33 feet, thence S 57°19'04"W for 18.40 feet, thence S 57°12'08"W for 15.48 feet, thence S 33°35'40"E for 43.23 feet, thence S 30°26'37"E for 35.88 feet, thence S 30°16'43"E for 25.30 feet, thence S 30°16'03"E for 32.73 feet, thence S 27°32'27"E for 37.31 feet, thence S 17°15'20"E for 29.12 feet, thence N 57°40'44"E for 110.23 feet to the point of beginning, containing 20,880.0179 square feet or 0.479339 acres more or less.

C. The facility authorized shall have a suitable appearance compatible with Creek Nation Bingo River Spirit Casino.

SECTION TWO. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
