A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 37, CHAPTER 4 ENTITLED "CONFLICT OF INTEREST"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. MCNCA, Title 37, Chapter 4, shall be amended and replaced in its entirety with the following; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and subchapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. <u>AMENDMENT</u>. MCNCA Title 37, Chapter 4, is hereby amended to read as follows:

TITLE 37. TRIBAL GOVERNMENT CHAPTER 4. CONFLICT OF INTEREST

§4-101. Prohibition.

- A. No officer or employee of the Muscogee (Creek) Nation or officer or employee of any entity under the jurisdiction of the Muscogee (Creek) Nation shall be permitted to enter into business contracts or do business with the Muscogee (Creek) Nation.
- B. Exemptions to subsection A applies to: 1) employees of the Nation that receive pay for teaching part-time or as an adjunct professor for the College of the Muscogee (Creek) Nation, 2) employees exempted under MCNCA Title 22, 4-108, C.3, and 3) employees of the Nation who possess special skills and services of cultural significance that would receive pay for providing services or classes that would help to preserve and educate others on the heritage, traditions, and/or culture of the Muscogee (Creek) Nation and 4) employees of the Nation who possess special skills and services related to law enforcement that would receive pay for providing services.

including the sale of trained K-9 for law enforcement purposes, or classes that help to preserve and ensure the safety and protection of the Muscogee (Creek) Nation.

SECTION THREE. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

ENACTED by the Muscogee (Creek) National Council on this 27th day of July, 2019.
