**CLASSIFICATION: #7. CITIZENSHIP/CENSUS**

### **A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 7, § 2-110 TO INCREASE THE STIPEND OF THE CITIZENSHIP BOARD MEMBERS**

**Be it enacted by the National Council of the Muscogee (Creek) Nation:**

**SECTION ONE. AMENDMENT.** These amendments shall be codified in Title 7, Chapter 2 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2003 by west Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

**SECTION TWO. AMENDMENT. MCNCA Title 7 § 2-110 is hereby amended to read as follows:**


§ 2-110. Compensation of Citizenship Board members

Each member of the Citizenship Board shall be paid a stipend for attendance of each Citizenship Board meeting. The stipend for each Citizenship Board member shall be three five hundred fifty dollars (\$3500.00) per meeting; provided, however, that stipends shall not be paid for more than fifty (50) meetings per year.

**SECTION THREE. EFFECTIVE DATE.** This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

**ENACTED** by the Muscogee (Creek) National Council on this 28<sup>th</sup> day of September, 2019.


