**CLASSIFICATION: #37. TRIBAL GOVERNMENT** 

A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 37, § 2-119 ENTITLED, "Mvskoke (Creek) Nation Pageant and Royalty"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

**SECTION ONE.** <u>AMENDMENT</u>. This amendment shall be codified in Title 37, Chapter 2, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

**SECTION TWO.** <u>AMENDMENT</u>. MCNCA Title 37, § 2-119. is hereby amended to read as follows:

TITLE 37. TRIBAL GOVERNMENT
CHAPTER 2. BUDGET AND FINANCE
SUBCHAPTER 1. REQUIRED ANNUAL BUDGET ITEMS

§ 2-119. Mvskoke (Creek) Nation Pageant and Royalty

The Mvskoke (Creek) Nation Pageant and Royalty shall be under the Office of Public Relations Mvskoke Nation Youth Services and an annual appropriation of \$37,080.00 shall be included in the Comprehensive Annual budget for expenses associated with the Mvskoke (Creek) Nation Pageant, Royalty activities, and for travel and/or clothing expenses of Miss Muscogee (Creek) Nation and Jr. Miss Muscogee (Creek) Nation and any remaining funds shall be returned to the appropriate treasury account and be available for future appropriation by the National Council. Said funds will be administered in accordance with a budget prepared by the Royalty Coordinator with the advice and consent of the Pageant Committee Officers. There shall be additional funding in the Comprehensive Annual Budget beginning Fiscal Year 2019 and annually thereafter for a full-time Royalty Coordinator who shall report directly to the Public Relations Mvskoke Nation Youth Services Manager with recommendations submitted by the Pageant Committee Officers.

**SECTION THREE.** <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.



Said funds will be administered in accordance with a budget prepared by the Royalty Coordinator with the advice and consent of the Pageant Committee Officers. There shall be additional funding in the Comprehensive Annual Budget beginning Fiscal Year 2019 and annually thereafter for a full-time Royalty Coordinator who shall report directly to the Mvskoke Nation Youth Services Manager with recommendations submitted by the Pageant Committee Officers.
