A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 48, CHAPTER 2, § 2-102 ENTITLED "TRIBAL WORKERS' BENEFIT ADVISORY COUNCIL MEMBERSHIP"

Be it Enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. This amendment shall be codified in Title 48, § 2-102 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws; and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. <u>AMENDMENT</u>. MCNCA Title 48, § 2-102 is hereby amended to read as follows:

§ 2-102. TWBAC membership

The TWBAC shall be comprised of five (5) persons holding the following positions:

- A. The Muscogee (Creek) Nation Personnel Human Resources Manager, or his/her designee;
- B. The Human Resources Director for <u>Muscogee</u> (Creek) Nation Tulsa Casinos or his/her designee;
 - C. The Muscogee (Creek) Nation Controller or his/her designee;
- D. An Employee of the Muscogee (Creek) Nation selected by the Muscogee (Creek) Nation Executive Director Principal Chief; provided that said employee shall not be a Deputy Director of the Nation;

E. Tribal Trade and Commerce Authority Human Resources Director;

F<u>E.</u> Muscogee (Creek) Nation Business Enterprise <u>Muscogee International</u> Human Resources Director <u>or his/her designee</u>; and

GF. A physician at the Okmulgee Indian Health Center. A person shall serve on the TWBAC so long as that person holds the position qualifying the person to serve on the TWBAC.

SECTION THREE. EFFECTIVE DATE. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
