A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 35, § 14-103 ENTITLED "ELIGIBILITY; GUIDELINES AND POLICY"

Be it Enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. This amendment shall be codified in Title 35, § 14-103 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws; and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. AMENDMENT. MCNCA Title 35, §14-103 is hereby amended to read as follows:

§ 14-103. Eligibility; Guidelines and Policy

A. Eligibility – It shall be the policy of the Muscogee (Creek) Nation to assist all enrolled youth Citizens, up to the age of 24, to participate in educational activities and non-educational extra-curricular activities. Eligibility, **funding categories, and amounts** will be determined by the ~~guidelines established and adopted by~~ **Director of the Youth Services Director and program with advisement from the Mvskoke Nation Youth Council Grant Committee – Finance Committee.**

- ~~1. Assistance may be paid up to 50% of total expenses, but not to exceed \$250.00 per individual; per fiscal year for non-educational extra-curricular activities.~~
- ~~2. Assistance for domestic educational activities and leadership opportunities that require domestic travel shall be 50% of total expenses, but no more than \$1,000.00 per individual; per fiscal year.~~


- ~~3. Assistance for international educational activities and leadership opportunities that require international travel shall be 50% of total expenses, but no more than \$2,000.00 per individual, per fiscal year.~~

B. Guidelines and Policy – The Director of the Youth Services Program, ~~along with the Youth Council Grant Committee,~~ will develop and adopt guidelines and procedures for administering the Mvskoke Youth Opportunity Grant, **with advisement from the Mvskoke Nation Youth Council – Finance Committee.** The Youth Services program Director will submit a copy of the guidelines and procedures, as adopted and any amendments, within ten (10) business days of being approved to National Council. All proposed guidelines and policies should first be submitted to the Office of the Attorney General for review before adopted.

SECTION THREE. EFFECTIVE DATE. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.






