A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 31, § 3-101 ENTITLED, "Compensation for certain officers or employees of the Muscogee (Creek) Nation"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>AMENDMENT.</u> The amendment shall be codified in Title 31, Chapter 3, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts for the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated in this law in order to be consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws; and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. <u>AMENDMENT.</u> MCNCA Title 31, § 3-101, is hereby amended to read as follows:

§ 3-101. Compensation for certain officers or employees of the Muscogee (Creek) Nation.

With the exception of Doctors, Dentists, Lawyers, Professional Engineers, Pharmacists, Nurse Practitioners, Physician Assistants, <u>Health Department Professionals</u>, the Director of the Department of Health, the Chief Information Officer, the General Manager of the Muscogee Nation Business Enterprise, the Public Gaming Commission Executive Director, and the Controller employed within the Muscogee (Creek) Nation, no other person who receive compensation with funds owned by or under the jurisdiction of the Muscogee (Creek) Nation shall be compensated in an amount which exceeds compensation established by ordinance for the Principal Chief of the Muscogee (Creek) Nation.

SECTION THREE. <u>EFFECTIVE DATE.</u> This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
