A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 19, § 2-117 ENTITLED "COMPENSATION OF INSPECTORS, JUDGES, CLERKS AND PRECINCT WORKERS"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. This amendment shall be codified in Title 19, Chapter 2, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized (1) to approve any changes related to the manner in which sections, articles, chapters and subchapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws; and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. AMENDMENT. MCNCA Title 19, § 2-117 is hereby amended to read as follows:

§ 2-117. Compensation of inspectors, judges, clerks and precinct workers

The inspector, judge, clerk and precinct workers, if any be appointed, shall each be paid a stipend at a rate set by the Election Board. <u>Tribal Employees shall be eligible to be inspectors, judges, clerks and precinct workers, but shall only be eligible for flex time for the number of hours worked. Tribal Employees shall not be paid a <u>stipend</u>. Mileage reimbursement, for actual miles driven, shall be paid in accordance with Muscogee (Creek) Nation regulations. Alternates shall be paid on the same basis as other Precinct Election Committee Members.</u>

SECTION THREE. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
