A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING NCA 21-084 (A LAW OF THE MUSCOGEE (CREEK) NATION REPEALING MCNCA TITLE 16, CHAPTER 4 AND CREATING NEW LAW IN A NEW TITLE 50, ENTITLED "LIGHTHORSE POLICE" AND AUTHORIZING AN APPROPRIATION FOR THE LIGHTHORSE POLICE COMMISSION)

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>AMENDMENT</u>. SECTION FOUR. APPROPRIATION of NCA 21-084 is hereby entitled to read as follows:

SECTION FOUR. <u>APPROPRIATION</u>. The sum of One Hundred Twelve Thousand, Three Hundred Seventy-Two and No/100 Dollars (\$112,372.00) is hereby appropriated from the Interest on Permanent Fund Account for the implementation of this Act <u>and shall be in the Comprehensive Annual Budget beginning fiscal year 2022 and annually thereafter. All unexpended funds appropriated by implementation of this Act shall be returned to the Tribal Treasury and shall be available for future appropriation by the National Council. Funds shall be carried forward until fully expended.</u>

SECTION TWO. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

ENACTED by the Muscogee (Creek) National Council on this <u>10TH</u> day of <u>November</u>, **2021**.
