

## NCA 22-018

**CLASSIFICATION: #36. TAXATION AND REVENUE** 

A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 36 § 3-108 ENTITLED "License plate"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>AMENDMENT</u>. This amendment shall be codified in Title 36, Chapter 3, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws; and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

**SECTION TWO.** AMENDMENT. MCNCA TITLE 36 § 3-108 A. 2. is hereby amended to read as follows:

2. Each license plate shall bear the name <u>Muscogee Nation</u>, <u>which due</u> <u>to space limitations on the license place shall mean the Muscogee</u> (Creek) Nation, <u>unless otherwise provided herein</u>,

**SECTION THREE.** <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

**ENACTED** by the Muscogee (Creek) National Council on this <u>26<sup>th</sup></u> day of <u>February</u>, <u>2022</u>.
