



## NCA 22-024

**CLASSIFICATION: #11. COMMUNITIES**

**A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 11 § 3-201, ENTITLED “CMD Fund” AND § 6-303, ENTITLED “Audits”**

**Be it enacted by the National Council of the Muscogee (Creek) Nation:**

**SECTION ONE. AMENDMENT.** This amendment shall be codified in Title 11 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Office of the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters, and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publication Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

**SECTION TWO. AMENDMENT.** MCNCA Title 11 § 3-201 B. shall be amended to read as follows:

§ 3-201. CMD Fund

B. Funds may not be used for: Community Board/Committee member stipends; salaries and payroll; personal mileage; personal rent or mortgage; personal loans; cash donations; to schools/churches/individuals; travel expenses related to overnight trips; purchase of vehicle(s); per capita payments; board meals; or mobile phones. **Exception, in the event that Muscogee (Creek) Nation hosts an event outside of the reservation, CMD Funds may be used for overnight stays in accordance with the Nation’s Travel Policy.**

**SECTION THREE. AMENDMENT.** MCNCA Title 11, § 6-303, D. shall be amended to read as follows:

§ 6-303. Audits


D. The National Council shall appropriate necessary funding for the Executive Administration to employ a Public Accountant to be assigned to the ~~Controller’s office~~ **Community Research and Development** to provide technical assistance to the

Chartered Communities and to facilitate the preparation and completion of the annual summary reports of the applicable Chartered Communities.

**SECTION FOUR. EFFECTIVE DATE.** This Act shall become effective upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

**ENACTED** by the Muscogee (Creek) National Council on this 26<sup>th</sup> day of March, 2022.


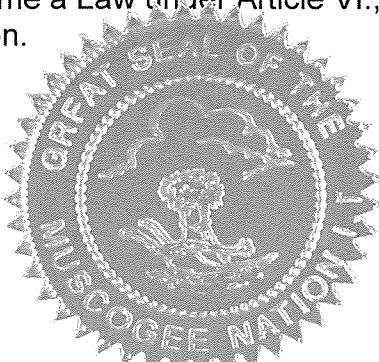
