A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING NCA 21-155 (A LAW OF THE MUSCOGEE (CREEK) NATION REPEALING MCNCA TITLE 17, CHAPTER 8, ENTITLED "GAMING OPERATIONS AUTHORITY BOARD")

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. NCA 21-155 is amended to read as follows:

SECTION ONE. <u>FINDINGS</u>. The National Council finds that:

- A. Gaming for the Muscogee (Creek) Nation is a multi-million dollar industry that has progressed beyond its original and current structure that was established in 1991.
- B. Currently, the Gaming Operations Authority Board is charged with administering and managing the Nation's gaming facilities and operations pursuant to MCNCA Title 17, Chapter 8.
- C. There is a need to repeal MCNCA Title 17, Chapter 8 to replace the GOAB with a Tribal Limited Liability Company to administer and manage the Nation's gaming facilities and operations to effectively maneuver the ever-changing industry.
- D. Chapter 8 of MCNCA Title 17 titled "Gaming Operations Authority Board" will be repealed and removed from MCNCA Title 17 by this resolution and a Tribal Limited Liability Company will be approved by a separate Tribal Resolution directing the Nation to file proper documents with the Secretary of Commerce.

SECTION TWO. <u>REPEALER AND EFFECTIVE DATE OF REPEALER</u>. Title 17, Chapter 8 is hereby repealed in its entirety **as of September 30, 2022**.

SECTION THREE. SUSPENSION OF POWERS AND AUTHORITIES OF GOAB. All Authorities and powers of the GOAB shall be suspended in regard to regular day-to-day operations of the Nation's gaming facilities. All operations shall be transferred to Muscogee Nation Gaming Enterprises, LLC; and, only transfer and dissolution activities of the GOAB shall commence until MCNA Title 17, Chapter 8 is repealed in accordance with this law as of September 30, 2022.

SECTION THREE FOUR. EFFECTIVE DATE. This Act shall become effective upon the proper approval and execution of this Act in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
