A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 22, CHAPTER 9, ENTITLED "EMERGENCY MANAGEMENT AUTHORITY"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>AMENDMENT.</u> These amendments shall be codified in Title 22, Chapter 9 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. <u>AMENDMENT</u>. MCNCA Title 22, § 9-105 entitled "Appropriation" is hereby amended to read as follows:

§ 9-105. Appropriation

The amount of four <u>five</u> hundred thousand and no/100 dollars (\$4<u>5</u>00,000.00) is hereby appropriated from the General Tax License Fund Account for the implementation of this Act. All unexpended funds appropriated shall be carried over until fully expended.

SECTION THREE. <u>AMENDMENT</u>. MCNCA Title 22, § 9-107 entitled "Authorization" is hereby amended to read as follows:

§ 9-107. Authorization

The National Council hereby authorizes the Principal Chief or his designee to expend the sum of four<u>five</u> hundred thousand and No/100 Dollars (\$4<u>5</u>00,000.00) from the General Tax and License Fund Account. This appropriation shall be included in the Fiscal Year 2008 <u>2023</u>Comprehensive Annual Budget and annually thereafter.

SECTION FOUR. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon property approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
