A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 37 § 2-123 ENTITLED "Este Cate Veterans (MVSKOKE Nation) Honor Guard

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. FINDINGS. The National Council finds that:

- A. NCA 22-142 establishes the Este Cate Hoktyke Suletawy Honor Guard.
- B. There is a need to include funding for the Honor Guard in the Comprehensive Annual Budget annually.

SECTION TWO. AMENDMENT. This amendment shall be codified in Title 37 § 2-123, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws; and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

§ 2-123. Este Cate Veterans (MVSKOKE Nation) Muscogee (Creek) Nation Official Honor Guards

There will be an annual appropriation in the amount of eighty thousand dollars (\$80,000.00), Forty thousand dollars (\$40,000.00) beginning with the FY 20234 Comprehensive Annual Budget, for the Muscogee (Creek) Nation Official Honor Guards Este Cate Veterans (MVSKOKE Nation) Honor Guard. Forty thousand dollars (\$40,000.00) shall be distributed each to the Mvskoke Este Cate Veterans and Este Cate Hoktvke Suletawy Honor Guards. All funds shall carry over until fully extended.

SECTION THREE. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
