A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 16, CHAPTER 1 §1-102 ENTITLED "THE ORGANIZATION FOR THE EXECUTIVE OFFICE OF THE PRINCIPAL CHIEF" TO ORGANIZE VARIOUS CULTURAL AND HUMANITIES PROGRAMS BY CREATING A NEW CULTURE AND HUMANITIES DEPARTMENT

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. FINDINGS. The National Council finds that:

A. The Muscogee (Creek) Nation has experienced a period of growth and expansion of programs that require an examination of its existing governmental structure within the cultural programs.

B. The purpose of this Act is to organize various cultural and humanities programs throughout the Department of Culture and Humanities. This organization will allow for more direct oversight and administration of the various cultural resource programs.

C. Additional amendments to the organizational statute of the Executive Office is necessary to better reflect the operation and existence of current programs in order to improve the effectiveness, efficiency, and accountability to the citizens of the Muscogee (Creek) Nation.

SECTION TWO. AMENDMENT. This amendment shall be codified in Title 16, Chapter 1, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purpose of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Office of the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters, and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publication Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION THREE. AMENDMENT. MCNCA Title 16, §1-102 shall be amended to read as follows:


