A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING NCA 22-142 (A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 15 CHAPTER 1. ENTITLED OFFICIAL HONOR GUARD TO ESTABLISH A WOMEN'S HONOR GUARD AND APPROPRIATING FUNDS FOR THE ESTE CATE HOKTVKE SULETAWV HONOR GUARD)

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. FINDINGS. The National Council finds that:

- A. NCA 22-142 established the Este Cate Hoktvke Suletawv Honor Guard ("Honor Guard") and appropriated funds for the start up of the Honor Guard.
- B. The Honor Guard is requesting NCA 22-142 be amended to allow it to purchase a recreational vehicle ("RV")
- C. Utilizing an RV would be more feasible instead of the passenger van and the trailer, as it would save on the costly expenses of hotel rooms and meals.

SECTION TWO. AMENDMENT. NCA 22-142, SECTION FOUR. is hereby amended to read as follows:

SECTION FOUR. <u>AUTHORIZATION</u>. The National Council hereby authorizes the Principal Chief or his designee to expend the sum One Hundred Five Thousand and No/100 Dollars (\$105,000.00) from the Interest on Permanent Fund Account for an passenger van, trailer <u>RV</u>, uniforms, flags, equipment and other necessary items for the Este Cate Hoktvke Suletawy Honor Guard to be fully operational.

SECTION THREE. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
