A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 35, CHAPTER 6 ENTITLED "SCHOOL CLOTHING PROGRAM"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. This amendment shall be codified in Title 35, § 6-103, § 6-105, and § 6-106, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. AMENDMENT. MCNCA Title 35, § 6-103 E., is hereby amended to read as follows:

CHAPTER 6. SCHOOL CLOTHING PROGRAM

§ 6-103. Administration/Distribution of grants

~~E. Three Hundred Forty One Thousand, One Hundred Fourteen and No/100 Dollars (\$341,114.00) of the total appropriation shall be allocated for administrative costs. Any funds remaining after administrative costs are expended shall be utilized for the School Clothing Program.~~

SECTION THREE. AMENDMENT. MCNCA Title 35, § 6-105, is hereby amended to read as follows:

§ 6-105. Appropriation

The sum of Four ~~Three~~ Million, Sixty-Four ~~Seven Hundred Twenty-Three~~ Thousand, One Hundred Fourteen and No/100 Dollars (\$~~341,114,000~~**43,064,723,114,000**.00) is hereby appropriated from funds designated by the Controller's Office for the Implementation of this Act.

SECTION FOUR. AMENDMENT. MCNCA Title 35, § 6-106, is hereby amended to read as follows:


§ 6-106. Authorization

The National Council hereby authorizes the Principal Chief to expend the sum of ~~Four~~ **Three** Million, ~~Sixty-Four~~ **Seven Hundred Twenty-Three** Thousand, ~~One Hundred Fourteen~~ and No/100 Dollars (\$~~43,064,723,114,000~~.00) from funds designated by the Controller's Office for the School Clothing Program. This appropriation shall be included in the Comprehensive Annual Budget for the Fiscal Year 2024 and annually thereafter. Funds shall carry forward until fully expended.

SECTION FIVE. EFFECTIVE DATE. This Act shall become effective January 1, 2024 upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

ENACTED by the Muscogee (Creek) National Council on this 1st day of June, 2023.


