A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING NCA 13-316 (A LAW OF THE MUSCOGEE (CREEK) NATION CREATING A NEW MCNCA TITLE 28, CHAPTER 9 ENTITLED "MUSCOGEE (CREEK) NATION NATURAL RESOURCE CONSERVATION DISTRICT" AND APPROPRIATING SAID FUNDS)

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>AMENDMENT.</u> NCA 13-316, Section Three and Section Four are hereby amended to read as follows:

SECTION THREE. <u>APPROPRITION</u>. The sum of Three Hundred Thousand and No/100 Dollars (\$300,000.00) is hereby appropriated from the Gaming Fund Account for the Muscogee (Creek) Nation Natural Resource Conservation District for FY 2014. Any funds remaining shall carry forward into the new fiscal year until fully expended.

SECTION FOUR. <u>AUTHORIZATION</u>. The National Council hereby authorizes the Principal Chief to the sum of Three Hundred Thousand and No/100 Dollars (\$300,000.00) is hereby appropriated from the Gaming Fund Account in accordance with the attached budget. <u>This appropriation shall be included in the Comprehensive Annual Budget annually thereafter and carry forward until fully expended.</u>

SECTION TWO. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

ENACTED by the Muscogee (Creek) National Council on this <u>27th</u> day of <u>February</u>. <u>2016</u>.
