

### NCA 16-027

**CLASSIFICATION: #16. EXECUTIVE BRANCH** 

A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 16, §3-106 ENTITLED "Office of the Attorney General"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>AMENDMENT</u>. This amendment shall be codified in Title 30 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

#### CHAPTER THREE. OFFICE OF THE ATTORNEY GENERAL

§3-106. Powers and duties

The duties of the Attorney General as the Chief Law Officer of the Muscogee (Creek) Nation shall be:

# S. Codification of the Nation's laws in accordance with the duties established in Title 30 §1-104 et seq. of this Code.

**SECTION TWO.** <u>EFFECTIVE DATE</u>. This Act shall become effective immediately. In the event that any provision of this Code is held to be unconstitutional or unenforceable, all other provisions of this Code shall remain in full force and shall be construed in a manner to effectuate the purpose and intent of this Code.
