A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING NCA 15-238 (A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 35, CHAPTER 9, ENTITLED "Special Appropriations Guidelines," AND CREATING A NEW CHAPTER 13 ENTITLED "Mvskoke Youth Opportunity Grant")

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. FINDINGS. The National Council finds that:

A. NCA 15-238 created the Mvskoke Youth Opportunity Grant, which is administered by the Nation's Youth Services program.

B. Due to the high demand of the Nation's youth seeking financial assistance for educational and extra-curricular activities, there is a need to amend NCA 15-238 to increase additional funding.

SECTION TWO. AMENDMENT. §13-102 and Sections Four and Five of NCA 15-238 shall be amended to read as follows:

§13-102. Annual appropriation

The sum of ~~sixty-one hundred thirty~~ sixty one hundred thirty thousand and no/100 dollars (\$~~6130,000.00~~ 6130,000.00) shall be included in the Comprehensive Annual Budget beginning fiscal year 2017 and annually thereafter for the implementation of this act. At the end of each fiscal year, all unexpended funds shall be returned to the Nation's treasury.

SECTION FOUR. APPROPRIATION. The sum of ~~SixtyOne Hundred Thirty~~ SixtyOne Hundred Thirty Thousand and No/100 Dollars (\$~~6130,000.00~~ 6130,000.00) is hereby appropriated from the Interest on the Permanent Fund Account for the implementation of this Act. All unexpended funds appropriated by implementation of this Act shall be returned to the Tribal Treasury and shall be available for future appropriation by the National Council.

SECTION FIVE. AUTHORIZATION. The National Council hereby authorizes the Principal Chief or his designee to expend the sum of ~~SixtyOne Hundred Thirty~~ SixtyOne Hundred Thirty Thousand and No/100 Dollars (\$~~6130,000.00~~ 6130,000.00) from the Interest on the Permanent Fund Account for the Mvskoke Youth Opportunity Grant.

SECTION THREE. EFFECTIVE DATE. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

ENACTED by the Muscogee (Creek) National Council on this 30th day of April, 2016.




