A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 35 § 9-103 ENTITLED, "Special appropriation guidelines" AND § 13-103. ENTITLED, "Eligibility; Guidelines and Policy"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. This amendment shall be codified in Title 35 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. AMENDMENT. MCNCA TITLE 35 § 9-103 is hereby amended to read as follows:

C. All citizens 24 years and younger shall not be eligible for special appropriations through the National Council pursuant to this Section. But instead will be eligible for assistance through the Mvskoke Youth Council Grant opportunity as indicated in MCNCA TITLE 35 § 13-103 A. 4.

CD. Waiver of this title may only be made by two-thirds (2/3) vote of the full National Council.

DE. Any special appropriations or prior obligations approved prior to the enactment of this Amendment shall not be subject to these amendments.

SECTION THREE. AMENDMENT. MCNCA TITLE 35 § 13-103. is hereby amended to read as follows:

§13-103. Eligibility; Guidelines and Policy

A. Eligibility - It shall be the policy of the Muscogee (Creek) Nation to assist all enrolled youth Citizens, up to the age of 24, to participate in educational activities and opportunities and activities and opportunities that are not specifically a part of school curriculum. Eligibility will be determined by the guidelines established and adopted by the Youth Services Director and Youth Council Grant committee.

1. Assistance may be paid up to \$250.00 per individual; per fiscal year for activities and opportunities that are not specifically a part of school curriculum.
2. Assistance for domestic educational activities and other opportunities not specifically a part of school curriculum that require domestic travel shall be 50% of total expenses, but no more than \$1,000.00 per individual; per fiscal year.
3. Assistance for international educational activities and other opportunities not specifically a part of school curriculum that require international travel shall be 50% of total expenses, but no more than \$2,000.00 per individual; per fiscal year
4. All citizens 24 years and younger shall not be eligible for special appropriations through the National Council pursuant to MCNCA Title 35 § 9-103. But instead will be eligible for assistance through the Mvskoke Youth Council Grant opportunity.

SECTION FOUR. EFFECTIVE DATE. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

ENACTED by the Muscogee (Creek) National Council on this 18th day of June, 2016.
