CLASSIFICATION: #37. TRIBAL GOVERNMENT

A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 37, CHAPTER 2, ENTITLED "BUDGET AND FINANCE"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. This amendment shall be codified in Title 37, Chapter 2 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purpose of codification of sald amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Office of the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws; and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. <u>AMENDMENT</u>. MCNCA Title 37, §2-203 is hereby amended to read as follows:

§2-203. Permanent Fund

M. Investment Committee. The Investment Committee of the Muscogee (Creek) Nation shall consist of the following members: (1) The Principal Chief or his/her designee; (2) The Tribal Administrator or his/her designee; (3) The Controller or his/her designee; (4) The Attorney General or his/her designee; and (5) The Speaker of the National Council or his/her designee. All designees shall be selected from within the office/branch of government listed herein, Pursuant to MCNCA Title 37, §2-717.E.1-3, the Investment Committee shall be an advisory committee only, providing advice and recommendations to the Controller and the Principal Chief so they may carry out their banking/investment duties in Title 37, §2-717E.1-3.

SECTION THREE. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
