

**CLASSIFICATION: #16. EXECUTIVE BRANCH** 

A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 16, CHAPTER 8 ENTITLED "OFFICE OF THE SECRETARY OF THE NATION" AND ESTABLISHING A NEW OFFICE KNOWN AS OFFICE OF THE SECRETARY OF THE NATION AND COMMERCE

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>AMENDMENT</u>. This amendment shall be codified in Title 16, Chapter 8 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification said amendment and its Inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and; (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

**SECTION TWO.** AMENDMENT. MCNCA Title 16, Chapter 8 is hereby amended to read as follows:

# TITLE 16. EXECUTIVE BRANCH CHAPTER 8. OFFICE OF THE SECRETARY OF THE NATION AND COMMERCE

## § 8-101. Office of the Secretary of the Nation and Commerce

- A. There is hereby established the Office of the Secretary of the Nation and Commerce within the governmental structure of the Muscogee (Creek) Nation Department of Commerce, the head of which shall be the Secretary of the Nation and Commerce, appointed by the Principal Chief, confirmed by the National Council for the term of his/her appointment and removable in accordance with law.
- B. The Secretary of the Nation <u>and Commerce</u> shall be a cabinet-level position and an appointed office of the Muscogee (Creek) Nation. The Secretary of the Nation <u>and Commerce</u> shall be required to take an oath to uphold the Constitution of the Muscogee (Creek) Nation.

#### § 8-102. Qualifications and salary

- A. Qualifications. The position of the Secretary of the Nation <u>and Commerce</u> shall have the following minimum qualifications:
  - 1. Individual must possess a bachelor's degree with experience in the duties and responsibilities required by this position;
  - 2. Individual must be a Museegee (Creek) Nation citizen:
  - 23. Individual shall have no previous felony convictions and must be in good standing with all accredited institutions associated with his/her field of study or profession.

#### § 8-103. Duties and responsibilities

- A. The Office of the Secretary of the Nation <u>and Commerce</u> shall be the office of primary responsibility for all entities and person(s) seeking to do business with the Muscogee (Creek) Nation. The Secretary of the Nation <u>and Commerce</u> shall coordinate all activities associated with Titles 3 and 3A—Corporations and Partnerships of the Muscogee (Creek) Nation Code Annotated, including but not limited to, the Partnership Act, Limited Partnership Act, General Corporation Act and Limited Liability Act. The Secretary of the Nation <u>and Commerce</u> shall also coordinate all activities associated with Title 33 Uniform Commercial Code.
- B. The Secretary of the Nation <u>and Commerce</u> shall monitor the storage and use of the Great Seal of the Muscogee (Creek) Nation.
- C. The Secretary of the Nation <u>and Commerce</u> shall perform protocol functions for the Office of the Principal Chief and shall conduct negotiations with outside entities on behalf of the Muscogee (Creek) Nation when needed.
- D. The Secretary of the Nation <u>and Commerce</u> shall serve as the principal advisor to the Principal Chief and shall be responsible for the overall direction, coordination and supervision of the Executive Office's social and economic policy.
- E. The Office of the Secretary of the Nation and Commerce shall be the lead governmental agency responsible for the attraction and encouragement of commerce with businesses in and outside the Muscogee (Creek) Nation.
- F. The Myskoke Loan Fund Community Development and Financial Institution Program shall be established under the Office of the Secretary of the Nation and Commerce and operate pursuant to MCNCA Title 17, Chapter 9.

# G. The Secretary of the Nation and Commerce shall have direct oversight of the Office of Self-Governance.

<u>H</u>F. The Secretary of the Nation <u>and Commerce</u> shall perform additional duties not clearly delineated in this section as determined by the Principal Chief of the Muscogee (Creek) Nation.

**SECTION THREE.** Any provision within the Muscogee (Creek) Nation Code Annotated there appears the term "Office of the Secretary of the Nation," and/or the term "Secretary of the Nation," the same shall be construed to mean, and apply to the newly created office of "Secretary of the Nation and Commerce," and/or the term "Office of the Secretary of the Nation and Commerce".

SECTION FOUR. <u>EFFECTIVE DATE.</u> This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

ENACTED by the Muscogee (Creek) National Council on this 27th day of August, 2016.
