A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 15 § 4-102 ENTITLED "MUSCOGEE (CREEK) NATION CULTURAL CENTER & ARCHIVES DEPARTMENT REVOLVING FUND"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>AMENDMENT</u>. This amendment shall be codified in Title 15, Chapter 4 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification and amendment and its inclusion in pocket parts of the Code Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and subchapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and; (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. <u>AMENDMENT</u>. MCNCA Title 15 § 4-102, is hereby amended by adding a subsection § 4-102. C., to read as follows:

§4-102. Muscogee (Creek) Nation Cultural Center & Archives Department Revolving Fund

C. The Muscoges (Creek) Nation Cultural Center & Archives Department shall have the authority to use money from the Revolving Fund to purchase items to offer for sale to the public in a gift shop (Including an online gift shop). All income from the gift shop operations shall be deposited into the Revolving Fund and made available for the continual operation of said gift shop.

SECTION THREE. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
