

## NCA 17-025

CLASSIFICATION: #37. TRIBAL GOVERNMENT

A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 37, § 2-219 ENTITLED, "The Muscogee (Creek) Nation Eufaula Boarding School Scholarship Fund" AND AUTHORIZING THE EXPENDITURE OF FUNDS TO BE USED TO ASSIST EUFAULA DORMITORY RESIDENTS WITH OPERATIONS AND ACTIVITIES

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>FINDINGS</u>. The National Council finds that:

- A. TR 14-148 authorized the Principal Chief to renew a Business Lease with U.S. Cellular for the use of a cellular tower located on the Eufaula Dormitory site.
- B. MCNCA Title 37, § 2-219 created the Muscogee (Creek) Nation Eufaula Boarding School Scholarship Fund and is in need to be amended in order for the funds to assist with operations, activities and scholarships for the Eufaula Dormitory.
- C. The Eufaula Dormitory, under the direction of the Education, Employment & Training Secretary, shall administer the funds for operations, activities and scholarships. Additionally, the funds shall solely be for all residents of the Eufaula Dormitory.

SECTION TWO. <u>AMENDMENT</u>. This amendment shall be codified in Title 37, Chapter 2, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Attorney General is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION THREE. AMENDMENT. MCNCA Title 37 § 2-219 is hereby amended to read as follows:

§ 2-219. Eufaula Bearding School Scholarship Dormitory Operations Fund

A fund account for the Muscogee (Creek) Nation Higher Education Scholarship Foundation Eufaula Dormitory shall be established for all income generated through the use of a cellular tower located on the Eufaula Dormitory site to be deposited into the Muscogee (Creek) Nation Eufaula Bearding School Scholarship Dormitory Operations Fund. Revenue expended from the income generated shall be in compliance with Muscogee (Creek) Nation Procurement Policies and Procedures. This account is to be used for cellege scholarships operations, activities and educational initiatives scholarships by the Higher Education Scholarship Foundation Eufaula Dormitory to support the development education and retention of all Eufaula Dormitory residents.

SECTION FOUR. TRANSFER. The National Council hereby authorizes the Controller to transfer all funds from the Eufaula Boarding School Scholarship Fund to the Eufaula Dormitory Operations Fund to administer.

SECTION FIVE. <u>AUTHORIZATION</u>. The National Council hereby authorizes the expenditure of funds from the Eufaula Dormitory Operations Fund and all future income generated through the cellular tower located on the Eufaula Dormitory site for operations, activities and scholarships that support the development, education and retention of all Eufaula Dormitory residents.

SECTION SIX. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

ENACTED by the Muscogee (Creek) National Council on this 25th day of March, 2017.
