A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 18, CHAPTER 4, §4-107 B. 7. ENTITLED "Purpose and Authority of the College of the Muscogee Nation Board of Regents"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. FINDINGS. The National Council finds that:

A. The Board of Regents of the College of the Muscogee (Creek) Nation has adopted a Board Resolution requesting an amendment to Title 18, Chapter 4, Section 4-107 B.7. in order to run the day to day operations more efficiently and to plan for the future growth and development of the College.

B. Specifically, the continued growth of the College has caused the need to amend the expenditure authority delegated from the Board of Regents to the President from \$100,000 to \$150,000.

C. The expenditure authority will enable the President to carry out his/her duties to run the day to day operations more efficiently and specifically to have the ability to pay financial aid, personnel and other expenditures associated with College operations.

SECTION TWO. AMENDMENT. This amendment shall be codified in Title 18, Chapter 4 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and; (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION THREE. AMENDMENT. MCNCA Title 18, Chapter 4, §4-107 B.7. is hereby amended to read as follows:

§4-107. Purpose and Authority of College of the Muscogee Nation Board of Regents.

7. Expend funds received by the College of the Muscogee Nation; provided the Board may delegate its power to the President to expend up to one hundred fifty thousand dollars (\$150,000.00) for the benefit of the college.

SECTION FOUR. EFFECTIVE DATE. This Act shall become effective upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

ENACTED by the Muscogee (Creek) National Council on this 20th day of December, 2014.



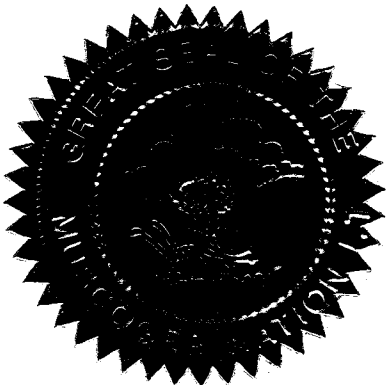


