A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 22, CHAPTER 3. ENTITLED "FIRE PROTECTION"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. These amendments shall be codified in Title 22, Chapter 3 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

TITLE 22. HEALTH AND SAFETY

CHAPTER 3. FIRE PROTECTION

SUBCHAPTER 1. AGREEMENTS OR COMPACTS

§ 3-101. Authorization

- A. The Muscogee (Creek) National Council authorizes the Principal Chief, or his designee, to negotiate and enter into an agreement/compact with municipal, county or rural fire districts for fire protection on Tribal and/or trust lands, or Indian owned lands throughout the Muscogee (Creek) Nation.
- B. The fee negotiated shall be consistent with the fees charges by the respective fire districts for fire protection on non-restricted lands.

SUBCHAPTER 2. GRANT PROGRAM FOR RURAL VOLUNTEER FIRE DEPARTMENTS

§ 3-201. Definitions

A. Firefighting equipment shall mean any necessary equipment, tools, supplies, or provisions for the purpose of this subchapter.

- B. New construction shall mean an original or new building built on site. New construction funds are not to be used to **construct** add additional structures to an existing building or **to construct** on a new site. The intent of new construction funds **isare** to assist those departments that do not currently have a structure in place.
- C. Maintenance or improvements shall mean any equipment, tools, vehicles, etc. necessary to enable the rural fire departments to improve and maintain the upkeep of the Rural Fire station/houses.
- D. Rural volunteer fire departments shall mean recognized firefighting organizations that exist to assist rural areas in the firefighting and fire prevention.

§ 3-202. Eligibility

Rural volunteer fire departments which have received ANY funding for firefighting purposes from the Nation ARE NOT eligible to apply for and are not receive funds for a period of three (3) years from the funding date that are located within the Nation's jurisdictional boundaries are eligible to apply for a grant if all requirements are met in § 3-203.

§ 3-203. Applications

- A. Rural volunteer fire departments must submit <u>an application</u> proposal to the Health, Education & Welfare Committee of the National Council for (1) new construction or (2) firefighting equipment or (3) maintenance or improvements. Funding for new construction is limited to five thousand dollars (\$5,000). Funding for firefighting equipment is two thousand dollars (\$2,000). Funding for maintenance or improvement is limited to five thousand dollars (\$5,000).
- B. Rural volunteer fire departments must submit a "Certificate of Incorporation."
- C. Rural volunteer fire departments must submit a "Certificate of Self Insurance" or equivalent verification of insurance.
- D. A line item budget and no less than three quotes must be submitted for all equipment or construction projects.
- E. Upon receiving a rural volunteer fire department grant, the grant recipient must agree to waive the annual fee(s) for all <u>Muscogee</u> (Creek) citizens that reside within the rural fire department district.

§ 3-204. Limitation on grants

Rural Volunteer fire departments may receive no more than five thousand dollars (\$5,000.00) assistance per requesteach fiscal year. A newly formed rural volunteer fire department would NOTshall not receive new construction and firefighting equipment funds collectively.

§3-205. Approval and Accountability

- A. The Tribal Affairs Health, Education & Welfare Committee of the National Council shall ferward provide the Principal Chief approved proposals a copy of each application for a grant that has been approved to the Chief's office after verifying pertinent information contained within the applications. Upon signature of the application by the Principal Chief, the Controller shall pay the grant award to the rural volunteer fire department.
- B. Each grant recipient shall expend funds in accordance with the approved grant budgets.
- C. Each grant recipient shall submit the following records for expenditures of a grant award within (30) days of completion of the awarded assistance project: involces or receipts with proof of payment evidenced by cancelled checks or other bank records. All records shall be provided to the Controller of the Muscogee (Creek) Nation.
- <u>D.</u> <u>Each grant recipient shall return any unexpended funds to the Controller for deposit in the Tribal Treasury.</u>
- E. In the event that a grant recipient does not turn in records as required by subsection C of this section, said grant recipient shall not be eligible to receive a grant award for a period of five (5) years and shall not be eligible to receive any financial assistance from the National Council and the Nation may seek full restitution of any and all funds received.

SECTION TWO. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.



- B. New construction shall mean an original or new building built on site. - C. Maintenance or improvements shall mean any equipment, tools, vehicles, etc. necessary to enable the rural fire departments to improve and maintain the upkeep of the Rural Fire station/houses.
- D. Rural volunteer fire departments shall mean recognized firefighting organizations that exist to assist rural areas in the firefighting and fire prevention.

§ 3-202. Eligibility

Rural volunteer fire departments that are located within the Nation's jurisdictional boundaries are eligible to apply for a grant if all requirements are met in § 3-203.

§ 3-203. Applications

- A. Rural volunteer fire departments must submit an application to the Health, Education & Welfare Committee of the National Council for (1) new construction or (2) firefighting equipment or (3) maintenance or improvements. Funding for new construction is limited to five thousand dollars (\$5,000). Funding for firefighting equipment is two thousand dollars (\$2,000). Funding for maintenance or Improvement is limited to five thousand dollars (\$5,000).
- B. Rural volunteer fire departments must submit a "Certificate of Incorporation."
- C. Rural volunteer fire departments must submit a "Certificate of Self Insurance" or equivalent verification of insurance.
- D. A line item budget and no less than three quotes must be submitted for all equipment or construction projects.
- E. Upon receiving a rural volunteer fire department grant, the grant recipient must agree to waive the annual fee(s) for all Muscogee (Creek) citizens that reside within the rural fire department district.

§ 3-204. Limitation on grants

Rural Volunteer fire departments may receive no more than five thousand dollars (\$5,000.00) each fiscal year. A newly formed rural volunteer fire department shall not receive new construction and firefighting equipment funds collectively.

§3-205. Approval and Accountability

- A. The Health, Education & Welfare Committee of the National Council shall provide the Principal Chief a copy of each application for a grant that has been approved. Upon signature of the application by the Principal Chief, the Controller shall pay the grant award to the rural volunteer fire department.
- B. Each grant recipient shall expend funds in accordance with the approved grant budgets.
- C. Each grant recipient shall submit the following records for expenditures of a grant award within (30) days of completion of the awarded assistance project; invoices or receipts with proof of payment evidenced by cancelled checks or other bank records. All records shall be provided to the Controller of the Muscogee (Creek) Nation.
- D. Each grant recipient shall return any unexpended funds to the Controller for deposit in the Tribal Treasury.
- E. In the event that a grant recipient does not turn in records as required by subsection C of this section, said grant recipient shall not be eligible to receive a grant award for a period of five (5) years and shall not be eligible to receive any financial assistance from the National Council and the Nation may seek full restitution of any and all funds received.
