A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 28, SUBCHAPTER 6-105 ENTITLED "The Master Plan"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. FINDINGS. The Nation Council finds that:

- A. The Cultural Center & Archives Department, in consultation with the Office of Interior Affairs, Tourism and Recreation, and the Tribal Planner is requesting to rename the designated area known as the, "Cultural Preservation Area", be renamed in order to honor Mike Berryhill.
- B. Mike Berryhill was a full-blood Muscogee (Creek) citizen, master bow maker Cvkotakse Hayv, and a member of the core group who formed Cvkotakse Seccvike the Mvskoke Bow Society.
- C. Mike Berryhill was an advocate for the preservation of culture, perpetuation of the Native Arts & Crafts and staunch supporter of Native American youth.
- D. The Cultural Center & Archives Department will obtain and pay for the necessary signage at the site.

SECTION TWO. AMENDMENT. The following amendment shall be codified in Title 28, Chapter 6 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said new law and its inclusion in pocket parts for the Code of Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated in this law in order to be consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws; and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following new law:


