A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 31, §3-101, TO ADD ADDITIONAL EMPLOYEES WHO CAN BE COMPENSATED MORE THAN THE PRINCIPAL CHIEF

Be it Enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. MCNCA Title 31, §3-101, is hereby amended to read as follows:


§3-101. Compensation for certain officers or employees of the Muscogee (Creek) Nation

With the exception of Doctors, Dentists, Lawyers, Professional Engineers, ~~Mid-level Health Professionals~~ **Pharmacists, Nurse Practitioners, Physician Assistants,** the Director of the Division of Health Administration, **the Chief Information Officer,** the General Manager of the Muscogee Nation Business Enterprise, the General Manager of the Tribal Trade and Commerce Authority and the Controller employed within the Muscogee (Creek) Nation, no other person who receives compensation with funds owned by or under the jurisdiction of the Muscogee (Creek) Nation shall be compensated in an amount which exceeds compensation established by ordinance for the Principal Chief of the Muscogee (Creek) Nation.

SECTION TWO. EFFECTIVE DATE. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

ENACTED by the Muscogee (Creek) National Council on this 24th day of April 2010.
