A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 35 §§9-103, ENTITLED "Special Appropriation Guidelines" AND 12-103, ENTITLED "Donation Guidelines"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. This amendment shall be codified in Title 35, Chapter 9, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

**SECTION TWO.** AMENDMENT. MCNCA Title 35 §9-103 B. 5. shall be amended to read as follows:

5. Communities — Requests for special appropriations from Communities may receive funding with a resolution from the Community Board of Directors or appropriate board or committee established with an approved budget. The budget shall be detailed with specific line items and receipts for expenditures shall be returned to the Controller of the Muscogee (Creek) Nation. Communities that have economic development shall be required to provide to the National Council the most recent financial statements and the most recent audited financial statements for the community and community business(es) upon requesting a special appropriation.

SECTION THREE. <u>AMENDMENT</u>. This amendment shall be codified in Title 35, Chapter 12, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections,

**SECTION FOUR.** AMENDMENT. MCNCA Title 35 §12-103 shall be amended by adding a Subsection G and shall be read as follows:

G. Waiver of this title may only be made by two-thirds (2/3) vote of the full National Council.

**SECTION FOUR. EFFECTIVE DATE.** This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
