**CLASSIFICATION: #37. TRIBAL GOVERNMENT**

**A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING NCA 08-153 (A LAW OF THE MUSCOGEE (CREEK) NATION APPROVING THE COMPREHENSIVE ANNUAL BUDGET FOR FISCAL YEAR 2009 AND PROVIDING FOR APPROPRIATIONS)**

**Be it Enacted by the National Council of the Muscogee (Creek) Nation:**

**SECTION ONE. AMENDMENT. NCA 08-153, Section 3-102., is hereby amended to read as follows:**

Section 3 - 102. Tribal Funds. Certain Tribal Funds and Expendable Trust Funds are estimated based on annualized year-to-date revenues and any known carry forward from prior years. Operating Funds, such as Enterprise and Internal Service funds, are based on estimated levels of expenditure and the revenue level necessary to cover such expenditures. Enterprise and Internal Service funds are "flexible".

Expendable Trust funds and Proprietary funds will be fixed while Operating type fund budgets may increase or decrease subject to revenue collected. All Operating Fund

budgets will be established at 100% of the total estimated expenses for the fiscal year, however, **expenses are limited by the availability of funds.** Increases in budgets which are funded either by Tribal funds or Expendable Trust Funds must be appropriated by the National Council. Any unobligated Tribal funds at September 30, 2009, with the exception of unexpended funds from the Health Administration/Division of Health, will be returned to the funding source for appropriations in future year budgets. Unexpended funds from the Health Administration/Division of Health shall carry forward until fully expended.

**SECTION TWO. EFFECTIVE DATE.** This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

**ENACTED** by the Muscogee (Creek) National Council on this **19th** day of **June 2010**.


**CERTIFICATION**
