CLASSIFICATION: #37. TRIBAL GOVERNMENT

A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 37 §2-121 ENTITLED "Grave preparation expenses" TO REPLACE LANGUAGE REGARDING STANDING COMMITTEE

Be it Enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. This amendment shall be codified in Title 37, Chapter 2 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. AMENDMENT. MCNCA Title 37, §2-121. is hereby amended to read as follows:

§2-121. Grave preparation expenses

With the approval of a budget and program guidelines by the Tribal Affairs Health, Education & Welfare Committee, the National Council hereby authorizes the Principal Chief to expend ten thousand dollars (\$10,000.00) for expenses related to the preparation of graves for Tribal citizens. This appropriation shall be included annually in the Comprehensive Annual Budget beginning in FY 2001 and thereafter.


SECTION THREE. EFFECTIVE DATE. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.
