**CLASSIFICATION: #37. TRIBAL GOVERNMENT**

**A LAW OF THE MUSCOGEE (CREEK) NATION REPEALING NCA 10-111, NCA 10-173, NCA 10-190, NCA 10-199 AND NCA 10-200**

**Be it enacted by the National Council of the Muscogee (Creek) Nation:**

**SECTION ONE. NEW LAW. The following new Law is hereby enacted:**

**Section 1-101. Findings. The National Council finds that:**

A. The National Council and the Office of the Principal Chief are engaged in litigation before the Supreme Court in two matters (SC 11-06 and SC 11-09).

B. The National Council and the Office of the Principal Chief are prepared to begin the process of healing and rebuilding from the circumstances that caused the litigation.

C. These cases involved a great deal of internal turmoil, individual stress, and with the election and new session of the National Council, the Parties are ready to move on from this difficult set of circumstances and have agreed to stipulate to dismissal of the matters and to vacate MCN District Court orders/decisions in those matters.

D. In order to accomplish the above, it is necessary to repeal NCA 10-111, NCA 10-173, NCA 10-190, NCA 10-199 and NCA 10-200.


**SECTION TWO. PURPOSE. The purpose of this Act is repeal NCA 10-111, NCA 10-173, NCA 10-190, NCA 10-199 and NCA 10-200.**

**SECTION THREE. REPEALER. NCA 10-111, NCA 10-173, NCA 10-190, NCA 10-199 and NCA 10-200 are hereby repealed.**

**SECTION FOUR. EFFECTIVE DATE. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.**

**ENACTED** by the Muscogee (Creek) National Council on this 5<sup>th</sup> day of July, 2012.
