**CLASSIFICATION: #37. TRIBAL GOVERNMENT** 

A LAW OF THE MUSCOGEE (CREEK) NATION CREATING NEW LAW IN TITLE 37 § 2-901, ENTITLED "Comprehensive Annual Budget-Requirements for Inclusion with New Programs"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. NEW LAW. The following new law shall be codified in Title 37, Chapter 2 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said new law and its inclusion in pocket parts for the Code of Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated in this law in order to be consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws; and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following new law:

## SUBCHAPTER 9. COMPREHENSIVE ANNUAL BUDGET- REQUIREMENTS FOR INCLUSION WITH NEW PROGRAMS:

# §2-901. Comprehensive Annual Budget – Requirements for Inclusion with New Programs

- A. For a new program to be included with each Comprehensive Annual Budget (without prior National Council authorization), such program shall satisfy the following requirements:
  - 1. Funded by the National Council over the past three (3) fiscal years:
  - 2. Annual presentations to the National Council showing progress of program since the initial appropriation for the program; and
  - 3. Provide documents to the National Council evidencing the expenditure of funds and the necessity of why the program should be included in the Comprehensive Annual Budget.

B. Only programs operated and conducted by the Muscogee (Creek) Nation shall be considered. No appropriations for outside contractors shall be considered by the National Council for inclusion in the Comprehensive Annual Budget for programs.

**SECTION TWO.** <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

**ENACTED** by the Muscogee (Creek) National Council on this <u>25<sup>th</sup></u> day of <u>October, 2014</u>.
