**A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING NCA 12-237 (A LAW OF THE MUSCOGEE CREEK NATION REPEALING CHAPTER 7 OF TITLE 6 ENTITLED, "MUSCOGEE (CREEK) NATION PATERNITY DETERMINATION CODE" AND REPLACING IT WITH A NEW CHAPTER 7 ENTITLED, "MUSCOGEE (CREEK) NATION PATERNITY DETERMINATION CODE")**

**Be it enacted by the National Council of the Muscogee (Creek) Nation:**

**SECTION ONE: AMENDMENT.** NCA 12-237, Title, is hereby amended to read as follows:

**A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING NCA 12-237 A LAW OF THE MUSCOGEE CREEK NATION REPEALING CHAPTER 7 OF TITLE 6 ENTITLED, "MUSCOGEE (CREEK) NATION PATERNITY DETERMINATION CODE" AND REPLACING IT WITH A NEW CHAPTER 7 ENTITLED, "MUSCOGEE (CREEK) NATION PARENTAGE DETERMINATION CODE"**

**SECTION TWO. EFFECTIVE DATE.** This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

**ENACTED** by the Muscogee (Creek) National Council on this 26<sup>th</sup> day of January, 2013.


**CERTIFICATION**
