**A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 15 §4-103 A. ENTITLED "Oversight Committee"**

**Be it Enacted by the National Council of the Muscogee (Creek) Nation:**

**SECTION ONE. AMENDMENT.** This amendment shall be codified in Title 15, Chapter 4 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

**SECTION TWO. AMENDMENT.** MCNCA Title 15, §4-103, A. is hereby amended to read as follows:


**§ 4-103. Oversight Committee**

There is hereby created a Muscogee (Creek) Nation Museum, Cultural Center and Archives Development Oversight Committee charged with oversight of planning for the operation, development and implementation of a Master Plan for a Muscogee (Creek) Nation Museum, Cultural Center and Archives. This Committee shall consist of the Principal Chief or designee, the Second Chief, one member and alternate from the Business Finance & Justice Committee, one member and alternate from the Health, Education & Welfare Committee one member and alternate from the Lands, Natural Resources & Cultural Preservation Committee, Traditional Expert Mike Berryhill, ~~the Muscogee (Creek) Nation District Court Judge~~, Dr. Betty Gerber and a Ceremonial Ground Mekko and alternate to be selected by the Muscogee (Creek) Nation Museum, Cultural Center and Archives Development Oversight Committee. The Director/Curator of the Museum of the Mvskokvlke shall serve as an ex-officio member of the Committee. The ex-officio member may participate in discussions and activities of the Committee but shall not make motions or vote.

**SECTION THREE. EFFECTIVE DATE.** This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

**ENACTED** by the Muscogee (Creek) National Council on this 25th day of February 2012.


