A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 16 §2-103 ENTITLED "Evaluation committee" TO REPLACE LANGUAGE REGARDING STANDING COMMITTEE

Be it Enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. AMENDMENT. This amendment shall be codified in Title 16, Chapter 2 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. AMENDMENT. MCNCA Title 16, Chapter 2, Compensation, Subsection 103. is hereby amended to read as follows:


§2-103 Evaluation committee

The compensation of the Principal Chief and Second Chief shall be evaluated every four years beginning on February 1, 2015 and every four years thereafter by a representative of the Executive Branch, Judicial Branch, Legislative Branch, and one Muscogee (Creek) citizen chosen by the Executive Branch and one Muscogee (Creek) citizen chosen by the Legislative Branch for a total of five representatives. The Representatives shall prepare a report and recommendations to be presented to the Business, Finance & Justice Governmental Committee no later than April 1.

SECTION THREE. EFFECTIVE DATE. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

ENACTED by the Muscogee (Creek) National Council on this 28th day of January 2012.




