**CLASSIFICATION: #22. HEALTH AND SAFETY**

**A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 22, CHAPTER 6, VISION ASSISTANCE PROGRAM, §6-104 ENTITLED "Benefits"**

**Be it enacted by the National Council of the Muscogee (Creek) Nation:**

**SECTION ONE. AMENDMENT.** This amendment shall be codified in Title 22, Chapter 6, Subchapter 1 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

**SECTION TWO. AMENDMENT.** MCNCA Title 22, §6-104, B. is hereby amended to read as follows:


### **§ 6-104. Benefits**

B. Each Creek citizen will be required to contribute a ten dollars (\$10.00) co-payment (or a useable pair of prescription eye glass frames) to be used toward the purchase of eyeglasses. After the co-payment, the program will provide up to one ~~one~~ **two** hundred ~~twenty-five~~ **forty** dollars (~~\$12450.00~~) of the remainder owed per person for each new eyeglass order or repair. Any amount over the total of to one ~~one~~ **two** hundred ~~twenty-five~~ **forty** dollars (~~\$12450.00~~) contributed to the Vision Assistance Program for eyeglasses/repairs will be the responsibility of the patient.

**SECTION THREE. EFFECTIVE DATE.** These Amendments shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

**ENACTED** by the Muscogee (Creek) National Council on this 18<sup>th</sup> day of May, 2013.



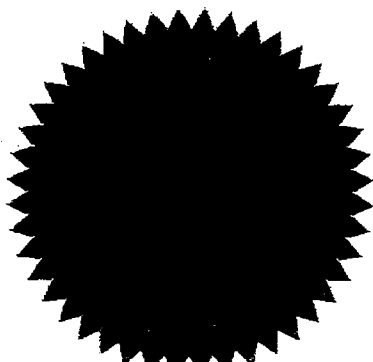


**§ 6-104. Benefits**

After the co-payment, the program will provide up to two hundred forty dollars (\$240.00) of the remainder owed per person for each new eyeglass order or repair. Any amount over the total of to two hundred forty dollars (\$240.00) contributed to the Vision Assistance Program for eyeglasses/repairs will be the responsibility of the patient.

**SECTION THREE. EFFECTIVE DATE.** These Amendments shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.




