**CLASSIFICATION: #37. TRIBAL GOVERNMENT**

**A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 37 §2-129, ENTITLED "Murrow Indian Children's Home"**

**Be it Enacted by the National Council of the Muscogee (Creek) Nation:**

**SECTION ONE. AMENDMENT.** This amendment shall be codified in Title 37, Chapter 2, of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification of said amendment and its inclusion in pocket parts of the Code of Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:


**SECTION TWO. AMENDMENT.** MCNCA Title 37, §2-129 is hereby amended to read as follows:

The Principal Chief is hereby authorized to expend/release seventy-five thousand and no/100 Dollars (\$75,000.00) annually to the appropriate officials of the Murrow Indian Children's Home. ~~This Section shall be an annual appropriation, beginning with FY 20012 Comprehensive Annual Budget. Beginning with the FY 2008 Comprehensive Annual Budget, the appropriation shall be increased to fifty thousand and no/100 dollars (\$50,000.00) and annually thereafter. That~~ The appropriation shall include a per capita of one hundred twenty-five and no/100 dollars (\$125.00) per student for Christmas gifts each year.

**SECTION THREE. EFFECTIVE DATE.** This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

**ENACTED** by the Muscogee (Creek) National Council on this 31st day of March 2012.


