**CLASSIFICATION: #37. TRIBAL GOVERNMENT**

**A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 37, §2-203 TO ALTER THE DISTRIBUTION OF FUNDS FOR A LIMITED PERIOD OF TIME FOR THE PURPOSE OF FUNDING THE BUDGET FOR FY 2013**

**Be it enacted by the National Council of the Muscogee (Creek) Nation:**

**SECTION ONE. Findings. The National Council finds that:**

A. There are insufficient funds in available accounts to fund the Fiscal Year 2013 Comprehensive Budget of the Nation. Therefore, it is necessary to temporarily authorize certain funds that have not been encumbered or utilized to be used towards funding the Fiscal Year 2013 budget.

B. The Debt Retirement Fund is normally restricted to fund early retirement of financed debts of the Muscogee (Creek) Nation; however, it is in the best interests of the Nation to lift the restriction temporarily and utilize the current funds that are available and not encumbered plus funds for the last quarter of Fiscal Year 2012 to be applied towards the 2013 budget.

**SECTION TWO. AMENDMENT. MCNCA TITLE 37, §2-203 is hereby amended to add a new section L. to read as follows:**


**L. All funds in the Debt Retirement fund accounts that have not been encumbered or utilized as of July 10, 2012 shall be used to fund the FY 2013 budget, regardless of the limitation set forth in §2-203(l). All funds that are deposited in the Debt Retirement Fund accounts for the fourth quarter of FY 2012 (July through September) pursuant to §2-203 shall be deposited in the Gaming Fund Account and shall be used in their entirety to fund the FY 2013 budget, regardless of the limitations.**

**This Subsection L shall only apply to the time limits mentioned in this section unless extended by legislative act.**

**SECTION THREE. EFFECTIVE DATE. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.**

**ENACTED** by the Muscogee (Creek) National Council on this 5<sup>th</sup> day of July, 2012.




