CLASSIFICATION: #17. ECONOMIC DEVELOPMENT

A LAW OF THE MUSCOGEE (CREEK) NATION REPEALING CHAPTER 7 OF TITLE 17 ENTITLED, "MUSCOGEE (CREEK) NATION ECONOMIC DEVELOPMENT COMMITTEE"

Be It Enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. FINDINGS. The National Council finds that:

A. NCA 10-201 (amended by NCA 11-112 and NCA 12-031) created Chapter 7 of Title 17 to establish the Muscogee (Creek) Nation Economic Development Committee ("Committee") charged with the oversight of the Nation's Economic Development Plan.

B. Since the enactment of NCA 10-201, the Nation has not pursued the Economic Development Plan due to various reasons, including a change in direction and vision from the current Administration.

C. Therefore, the Committee has outlived its purpose and the monthly meetings have become unproductive and a waste of resources.

D. It is necessary to repeal Chapter 7 of Title 17 and reappropriate the funds to the Department of Commerce to utilize for economic development purposes.

SECTION TWO. REPEALER. MCNCA Chapter 7 of Title 17 is hereby repealed in its entirety and any other legislation in conflict with this Act is hereby repealed.

SECTION THREE. EFFECTIVE DATE. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.

ENACTED by the Muscogee (Creek) National Council on this 29th day of June, 2013.


